

OFFICIAL CONTEST RULES

Contest entry period begins 0800 CST February 6, 2026 and ends 2359 CST February 19, 2026.

1. Who can enter: All authorized Exchange customers 18 years or older at the time of entry are eligible to enter, except employees of the Exchange (including military personnel assigned to the Exchange and Exchange retirees), its concessionaires, contractors or representatives providing in-store service or working in an Exchange facility, and the immediate family members of the above. Immediate family includes spouse, children, parents, persons in loco parentis and resident members of the employee's immediate household.

2. How to Enter: During the entry period, to submit a valid entry, Entrants must (a) take a photograph of what you deem to be the best smile; and (b) share the photograph at www.shopmyexchange.com/sweepstakes. Entries must include the name of the Entrant; Entrant's legal first name, last name, mailing address, email address, phone number, and local Exchange location. Limit one entry per person. The picture must be submitted in the form it was taken and may not be altered with computer software.

3. Selection of winner: Three (3) entries from among all eligible entries received will be chosen by a team of Exchange associates and deemed a Winner. All entries will be judged based on the following criteria: Originality, Creativity and Appropriateness to contest theme. Each Winner's eligibility will be subject to verification. The decisions of the Judges are final and binding on all matters related to this contest.

An entrant's failure to respond to the notification email or telephone call within seven calendar days of notification, or a notification email or prize being returned as undeliverable may result in prize forfeiture. Winners will be required to execute and return a Sweepstakes Acceptance Form and a Video/Photography Release Form within seven (7) calendar days of when the notice was sent, or the prize will be forfeited. If a prize is forfeited or unclaimed in accordance with this section, then the prize may not be awarded.
